### **POSITIVE PROFIT ALERT**

This announcement is made by DL Holdings Group Limited (the “**Company**”, and together with its subsidiaries, the “**Group**”) pursuant to Part XIVA of the Securities and Futures Ordinance (Chapter 571 of the Laws of Hong Kong) and Rule 13.09(2) of the Rules (the “**Listing Rules**”) Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (the “**Stock Exchange**”).

The board (the “**Board**”) of directors (the “**Directors**”) of the Company wishes to inform the shareholders of the Company (the “**Shareholders**”) and potential investors that, based on a preliminary review of the Company’s draft unaudited consolidated management accounts for the six months ended 30 September 2020, the Group is expected to record a net profit attributable to owners of the Company of not less than HK\$65.0 million for the six months ended 30 September 2020 as compared to a net loss attributable to owners of the Company of approximately HK\$47.5 million for the six months ended 30 September 2019. Based on the relevant information available, the Board considers that such expected turnaround from net loss to net profit was mainly attributable to (1) the expansion of the Group’s existing business to the provision of financial services which commenced in November 2019 and contribution of gross profit from the new financial services business for the six months ended 30 September 2020; and (2) there was fair value gain of financial assets for the six months ended 30 September 2020.

The information contained in this announcement is only based on a preliminary assessment by the Board based on the information currently available to the Company and the draft unaudited consolidated management accounts of the Company for the six months ended 30 September 2020 prepared by the management of the Company, which have not yet been confirmed or reviewed by the audit committee of the Company and have not yet been finalised as at the date of this announcement. The Company expects to publish an announcement on the interim results of the Group for the six months ended 30 September 2020 in or about mid November 2020 in accordance with the Listing Rules.

**The Shareholders and potential investors are advised to exercise caution when dealing in the shares of the Company and read the announcement of the interim results of the Company for the six months ended 30 September 2020 carefully when it is published.**
